KENTUCKY LEADERSHIP CONTENT NETWORK FACILITATOR AGREEMENT


This **LEADERSHIP CONTENT NETWORK FACILITATOR AGREEMENT**, made and entered by and between the **Ohio Valley Educational Cooperative**, 100 Alpine Drive, Shelbyville, KY (hereinafter referred to as the "Cooperative"), and Carroll County Public Schools (hereinafter referred to as "provider").

- 1. Employment.** The Cooperative contracts with Provider to provide facilitators for the work of the Kentucky Leadership Content Networks.
- 2. Term.** The term of this Agreement shall commence on July 1, 2012 and shall terminate at the conclusion of the KENTUCKY LEADERSHIP CONTENT NETWORK assignment described in section 3 below.
- 3. Duties.** Provider agrees to provide facilitation for district-based personnel participating in the KENTUCKY LEADERSHIP CONTENT NETWORK (Instructional Support / School Leaders Leadership Network) sessions provided by the Ohio Valley Educational Cooperative, under the direction of the Kentucky Department of Education, and to participate in all required training and preparation activities associated with the KENTUCKY LEADERSHIP CONTENT NETWORK assignments and responsibilities.
- 4. Compensation.** For all services rendered by Provider under this Agreement, Provider shall be compensated at the amount of \$2,050 which shall include travel unless additional travel is provided by the Kentucky Department of Education.

This Agreement contains all the terms and conditions agreed on by the parties hereto, and no other agreement (oral or otherwise) regarding the subject matter of this

Agreement shall be deemed to exist or bind any of the parties hereto. This Agreement may only be amended by a document in writing executed by both parties to this




