- o The new PGES (Professional Growth Evaluation System)the principals have been viewing modules each week to build personal information on the system. Next year we will have to evaluate 10% and the following year it will encompass all certified. The district will have to devise benchmarks with formative assessments for those that have non tested subjects within the state. We will be working with OVEC to ensure some continuity at least for our area.
- o Lindamood-Bell at Kathryn Winn, I'd like to brag on our teachers and our students because it has been a large self-esteem builder.
- Carroll County High School was recognized in the Washington Post for one of the most challenging high schools for the advanced placement subjects and testing.
   Our next endeavor will be adding college courses as well to move further along for College and Career Readiness.
- Young Leaders graduation was last week. The Carroll County Community Development Corporation devised the young leaders program for the High School sophomore. The sophomores throughout the year attend different modules with the CCCDC and train to build leadership qualities.
- Race to the Top Grant, is moving and I met with our Leadership Team and began working with them to stay on track with what is next with the grant. Kathryn Winn and Cartmell have decided to begin with the Stephen Covey Building Character Education and the Carroll County Middle School and Carroll County

- High School will begin with the Data Team Process. The following year the schools will switch.
- We held a Math Professional Leadership Training for the Instructional Leaders.
   Math standards are different at this time so OVEC and KDE Leadership presented and trained us on the differences on how to learn and have the students learning how to do the work.
