



Carroll County High School/Nike Agreement

Lowe's Sporting Goods & Nike are pleased to offer Carroll County High School a **NIKE/LOWE'S ALL SCHOOL DEAL** contract for the 2013-2016 seasons. This agreement will begin on July 1, 2013 and last through June 30, 2016. All athletic purchases by Carroll County High School (both coaches and office personnel) is to be purchased from Lowe's Sporting Goods, and cannot be purchased from any other vendor (unless otherwise discussed). Athletic purchases include all of the following: uniforms, athletic equipment, training aids, locker room materials, gym equipment, field equipment, coach apparel, player apparel, office administration apparel, headwear, goals, nets, scoreboards and footwear that is used anytime during practice or games.

Purchases & Promotional Benefits:

- Elite Team Discount of **35%** off All Nike stock and fundamentals.
- Elite Team Discount of **35%** off All Nike footwear and equipment.
- Digital Print, Custom, & Modified Custom will have its own price structure.
- Year one the SCHOOL will receive **\$8,000.00** in Nike Bucks
- Year two the SCHOOL will receive **\$7,000.00** in Nike Bucks
- Year three the SCHOOL will receive **\$5,000.00** in Nike Bucks

Nike bucks can be used to purchase any items in the stock and fundamentals line at listed retail price. Uniforms cannot be purchased using the Nike Bucks. Nike bucks are issued at the end of each fiscal year and only valid if all current invoices have been paid.

Guidelines for ordering:

- Approval by coach, and signed PO must be ready at time of order.
- Digital Print, Custom, & Modified Custom apparel must be ordered during the Nike Team ordering windows.
- Emergency requests need to be handled on an individual basis. Factors such as stock or special order items play a major role in turn-around time.
- Any item ordered that Lowe's Sporting Goods does not have in their warehouse will be ordered from the manufacturer. Therefore availability is dependant on manufacturers stock. Coaches/Customers will be notified of any backorder dates up front.
- Failure of delivery will be discussed on a per order basis.

Throughout the term of this contract Carroll County High School is required to convert all game worn uniforms, shoes, and coach gear to the Nike Brand, in ALL sports. Football is required to purchase only one new set of Nike Uniform pants or jerseys since they are currently in Nike. Carroll County High School is also required to have a Lowe's Sporting Goods banner or sign at every game sight on school grounds (gym, fields, etc). Camp T-shirts will not be Nike unless specified by the coach. The Lowe's Sporting Goods company logo may be located on the back neck or the sleeve of the shirts. During the term of the agreement all athletic personnel will purchase and wear Nike Product. This Contract is prepared in mutual agreement between Carroll County High School & Lowe's Sporting Goods for 3 years. The Carroll County High School has the right to cancel this contract at the end of each fiscal year. Notice of cancellation requires 30 days notice. If the contract is terminated Carroll County high School will be responsible for paying for half of the received Nike Bucks Gear. (example: if CCHS terminates the contract after year one, and they used all \$8,000.00 of their Nike Bucks; they will be responsible for paying \$4,000.00 worth)
