1. Call to Order/Roll Call

Mr. Hogan welcomed everyone and briefly explained that the school would have twenty (20) minutes to present to the board. After the presentation the board had twenty (20) minutes to ask questions. This is an informal meeting and they may ask questions during the presentation before each presentation.

- 2. 5:10p-5:50 Presentation of Carroll County High School SBDM Council Mr. Stephens presented the Carroll County High School goal, mission, vision, and motto. Mr. Stephens discussed the changes that they have made when ACT Testing. Students tested in the classroom instead of the gym which helped the students since they were in the same location and had that comfort. All testing scores were discussed along with the benchmarks. Mr. Stephens discussed the graduation rates and at this time all students are on track with graduation. Working on closing the gap the high school has implemented the guided advisory program and career advisory program. One program is three days a week and the other is two times a week. If the students are not reaching benchmarks the students are placed in interventions during this time. High school has been working on the co-teaching portion in the classroom. Brianna Miller, SBDM Teacher Representative elaborated on the co-teaching in the high school and how this program is growing yearly. Assessment testing, AP Testing, End of the Year Course Assessment tests were discussed. The curriculum and curriculum maps were discussed, as was the planning of the teachers in the core classes. Technology and how that has been integrated into the classroom was discussed. The high school is very appreciative of all the technology that has been provided for the students of Carroll County High School. More career pathways are being added to the students along with JCTC classes. Mr. Stephens, Valerie Washburn, Sheree Richter, Brianna Miller, Lisa Weedman, Bill Varble, Tina Dermon parent representative was present to talk to the board and answer questions. Mr. Stephens presented all components to the board and there was an open discussion between the Board and the CCHS SBDM Committee.

- **4. 6:20p-7:00p Presentation of Carroll County Middle School SBDM Council** Principal Dana Oak introduced her CCMS SBDM Council, Jeff Fremin, Instructional Coach, Beth Wallace, Guidance Counselor, Tina Wilson Assistant Principal, Kelly Hash Teacher Rep, Beth Sapp Teacher Rep., Lisa Nab Parent Representative, Lisa Osborne Parent Representative were present; *Renee Coghill Teacher Rep. was unable to attend.* Mrs. Oak discussed test scores, Mr. Fremin discussed the math that they are working on with Ms. Debbie Thompson and how the teachers are teaching concrete/abstract math. As part of the Race to The Top middle school has chosen problem based learning. They will start this

process with certain teachers and grow that process beginning next year. Assessments and testing across the school was discussed. Mrs. Oak presented all components to the board and there was an open discussion between the Board and the CCMS SBDM Committee.

5. 7:05p-7:45p Presentation of Alternative Learning Center SBDM Council Mr. Ed Nelson introduced his Alternative Learning Center Staff Crystal Raisor, Teacher, and Jo Ellen Hawkins, Receptionist. Tammy Welch, Social Worker was out of town attending training. Mr. Nelson explained what the Alternative Learning Center is about and how the school works with the students of Carroll County. He discussed the mission statement for the Alternative Learning Center. Explained that the Alternative Learning Center isn't a short term placement. The school works with students at a minimum of six months. Most of the students enjoy the school and environment which leads them to stay at the ALC instead of going back to their school. However if students decide to go back then the ALC works with those students to make sure that each one is prepared to return. Mr. Nelson presented to the board information about the Alternative Learning Center, what they are doing in the facility, the different incentives that are in place for the students, and the E20:20/Edgenuity Online Program. The E20:20/Edgenuity program is working wonderfully at the ALC and it is keeping the students engaged throughout the day. The program also assists the staff with data that allows them to see the progress of each student. The incentives that are in place keeps the atmosphere competitive but it also allows the students to work toward goals for themselves. Discussions about the other programs that are incorporated within the school were discussed briefly. At the end of the presentation there was an open discussion between the Board Members and the ALC Staff.
